



Volunteer Matching – Service Makes Cents

The Heart of Experian will make a \$500 donation for every 50 volunteer hours that an Experian employee serves at a non-profit organization.

Application: To participate in Experian's volunteer match program, employees must complete a service makes cents application and forward it to the non-profit organization for verification and sign off. The organization will complete the form and return it — along with 501c3 documentation — to Experian for review and processing.

Selection: The community involvement manager will review requests and determine funding.

Restrictions:

- Employees cannot combine volunteer hours accumulated at various organizations to meet the 50-hour requirement
- Employees may submit an application upon completion of the 50-hour requirement
- Relatives, including children of employees, are not eligible for this program
- There are no limitations on how many times an employee can request this donation
- The organization must be a non-profit and qualified with 501c3 status
- The services provided by the organization must not be religious or political in nature
- Requests must be submitted within six months of the 50-hour completion date

Timing: Applications are accepted throughout the year. Employees will be notified when an application has been processed.
